# SPEAKERS

## Mark Becton

Mark Becton is the senior pastor of Grove Ave. BC in Richmond and is completing his second term as president of the SBC of Virginia. He received his M.Div. and Ph.D. degrees from Southwestern Baptist Theological Seminary. He has served in pastorates for more than 20 years and has served as a member of the Committee on Committees (SBC) and a charter member of the Presidents Council (National Religious Broadcasters).

## Stephen Rummage

Stephen Rummage is the senior pastor of Bell Shoals BC in Brandon, FL. Rummage served as the second vice president of the SBC in 2009-10. He served as professor of preaching and director of the Doctor of Ministry Program at Southeastern Baptist Theological Seminary. Stephen received a B.A. from the Univ. of NC. He holds an M.Div. from Southeastern, and completed his Ph.D. in preaching and theology at New Orleans Baptist Theological Seminary.

## Tom Elliff

Tom Elliff currently serves as the president of the International Mission Board. He has served as the IMB's senior vice president for Spiritual Nurture and Church Relations. Elliff pastored for 42 years, during which time he served as the president of the SBC Pastors' Conference and two terms as president of the SBC. He is the founder of *Living in the Word Publications*, a writing and speaking ministry focused on the ongoing necessity of spiritual awakening. He is a graduate of Ouachita Baptist Univ. (B.A.), Southwestern Seminary (M.Div.), and Southern Seminary (D.Min.).

## Kevin Ezell

Kevin Ezell serves as the president of the North American Mission Board. He also serves on the Board of Reference for Union Univ., his alma mater. Ezell received an M.Div. from Southwestern Seminary in Fort Worth, TX, and a D.Min. from Southern Seminary in Louisville, KY. He most recently served as senior pastor of Highview BC in Louisville, KY for 14 years. Kevin has served as the chairman of the Committee on Committees of

the SBC and at Midwestern Seminary in Kansas City, where he was a trustee for five years and the chairman of the board for one term.

## Herb Reavis Jr.

Herb Reavis Jr. was born and raised in the panhandle of Texas. He is a graduate of the Moody Bible Institute, Milligan College, and the Southern Baptist School for Biblical Studies. He has been serving as senior pastor of N. Jacksonville BC in Jacksonville, FL since 1991. Reavis is seen throughout North Florida and Southeast Georgia on the weekly broadcasts of *Reach Out*. He is also heard daily on the *Reach Out* radio program on WROS in Jacksonville.

# *Minutes of the 2010 Annual Homecoming*

### **Sunday, Nov. 7, 2010 Evening Session**

The Convention Praise Team led in worship with *Victory in Jesus*; *Holy, Holy Holy*; and *Revelation Song*.

The host choir from Hyland Heights Baptist Church performed *Psalm 24*.

President Dr. Mark Becton welcomed all those present to the 2010 Annual Homecoming.

Rev. Carl Weiser, pastor of the host church and chairman of the Executive Board, gave welcome from Hyland Heights Baptist Church and opened the Annual Homecoming with prayer.

Special music was performed by the Hyland Heights Baptist Church choir—*Thou, O Lord*.

Rev. Jack Noble, church health strategist for the Central-West Region, introduced Rev. Jonge Tate, pastor of Bedrock Community Church in Bedford, who shared the first theme challenge.

The Convention Praise Team performed *Christ the Lord Is Risen Today* and *Worthy Is the Lamb/Crown Him*.

Dr. Bryan Smith, pastor of First Baptist Church in Roanoke, introduced Dr. Mark Becton, pastor of Grove Ave. Baptist Church in Richmond and SBCV president.

Special music was performed by the Hyland Heights choir—*I Believe God* and *Unto the Lamb*.

Becton delivered the president's message, *The Marks of Surrender*, from Mark 16.

Becton followed with announcements and reminded attendees about the question and answer time with Dr. Jeff Ginn, executive director, following the session in room D102.

Rev. Carlos Payan, pastor of Iglesia de las Americas in Lynchburg, gave the benediction.

### **Monday, Nov. 8, 2010 Morning Session**

The day began with praise and worship led by the Convention Praise Team.

President Mark Becton came to the stage to welcome the messengers and guests and introduce Rev. Danny Campbell, pastor of Wayne Hills Baptist Church, who led in prayer.

Rev. Steve Bradshaw, director of Maturing Churches, gave the convention attendees information and directions for the two breakout sessions that would occur during the rest of the morning.

### **Monday, Nov. 8, 2010 Afternoon Session**

The afternoon session was opened with music from LU Praise.

An SBCV 360 video was shared highlighting YEC; Pastors, Staff, & Pastors' Wives Retreat; and State-wide Church Planter Networks.

President Mark Becton introduced Dr. Ed Taylor, pastor of Amissville Baptist Church in Amissville, who led in prayer.

Music was provided by the Convention Praise Team—*Let The Praises Ring, Majestic, and To God Be the Glory*.

Becton introduced and welcomed Rev. David Andersen, state director, Virginia Capitol Commission, to pray for America and its leaders.

Special music was performed by Dr. Leo Day, minister of music at Olive Baptist Church in Pensacola, FL—*He's Got the Whole World in His Hands*.

Rev. Brandon Pickett, director of Media Services, introduced the Cooperative Program video, *We Are There*.

Becton asked messengers to submit proposed resolutions to Rev. Paul Davis Jr., chairman of the Resolutions Committee, by the end of the current session.

Becton announced that there were 692 messengers and guests present.

### **MOTION**

A motion was made to adopt the 2009 Annual Homecoming minutes found on pages 16 – 30 in the 2010 Annual Homecoming Guide. The motion passed unanimously.

### **MOTION**

A motion was made to adopt the 2010 Annual Homecoming program in the 2010 Annual Homecoming Guide. The motion passed unanimously.

Becton introduced the executive director, board chairman, 1<sup>st</sup> and 2<sup>nd</sup> vice presidents, secretary, parliamentarian, and executive board and asked them to stand to be recognized.

Becton recognized Jeff Ginn to give his report. Ginn spoke from Philippians and related the text

to the Ms in SBCV life: Maturing Churches, Multiplying Churches, and Mobilizing Churches.

Two churches were awarded the Macedonia Award for Cooperative Program Giving. Dr. Bryan Smith, pastor of First Baptist Church of Roanoke (top CP giver), and Rev. Donald Joyner, pastor of Matoaca Baptist Church in Matoaca (top CP giver per capita), accepted the awards for their churches.

### **RECOMMENDATION**

Becton asked Carl Weiser, chairman of the Executive Board, to give a report on the work of the Vision 20/20 Steering Team. The report can be found on pages 69 – 71 of the Annual Homecoming Guide.

Cards were distributed to encourage all present to partner with SBCV to pray for Vision 20/20 and commit to lead their churches to sponsor a new church plant, discover and take the next step to church health, engage actively in the Acts 1:8 Network, and make a 2020 commitment to increase CP giving.

Becton asked Rev. Jeremiah Sluss, pastor of Grace Fellowship Baptist Church in Haysi, to pray that God would work through SBCV churches to accomplish Vision 20/20 for His glory.

Becton called Rev. Robert Rowland, chairman of the Maturing Churches Committee, to present the Church Affiliation Report (page 72 in the Annual Homecoming Guide). Rowland presented 16 churches for affiliation with SBCV. There was no discussion, and the motion passed unanimously. A time of prayer for these 16 churches took place.

New pastors and ministry teams to the SBCV were welcomed and honored.

Becton called Dr. Doyle Chauncey, president of SBCV Foundation and Church Ministry Services and SBCV assistant treasurer, to the platform. Chauncey presented the 2011 Ministry Investment Plan found on pages 35 – 40 of the Annual Homecoming Guide.

### RECOMMENDATION

Chauncey read the recommendation from the Executive Board: “The Executive Board recommends to messengers in the 2010 Annual Homecoming that the Proposed 2011 Cooperative Program Ministry Investment Plan in the amount of \$9,000,000 be adopted.” It was announced that the vote would take place Tuesday morning and that Chauncey would be available for questions after the current session.

### RECOMMENDATION

Dr. Tom Lovorn, member of the Nominating Committee, directed attendees to the committee’s report found on pages 74 – 75 of the Annual Homecoming Guide. He read the recommendation: “The Nominating Committee recommends to messengers in the 2010 Annual Homecoming that persons nominated in this year’s meeting be approved to serve on the 2011 Executive Board of the SBCV. Note: Term expires at the end of the Annual Meeting of the year indicated.” A call for questions came from Becton, and there were none. The vote was unanimous.

Music was performed by Liberty University Praise.

Four seminaries were recognized, and representatives from each were called to the stage by Becton.

Mid-America, Southeastern, Southwestern, and Liberty representatives gave the messengers updates and greetings from their seminaries.

Becton introduced Rev. Darrell Webb, church health strategist for the North Region. Webb introduced Leo Day, who would be providing special music for the convention. Webb also introduced Rev. Kyle Kelley, middle school pastor at Spotswood Baptist Church, Fredericksburg. Kelley prayed for Day and the next theme challenge speaker, Rev. Banks Swanson, pastor of Shenandoah Community Fellowship, Woodstock.

Swanson spoke to the convention attendees from Romans 12:1 – 2 about the process of transformation that occurs in the believer’s life through the transforming power of Jesus Christ.

Music was led by the Convention Praise Team.

Rev. Bill Wennersten, church planting strategist for the North Region, gave the introduction and prayer for the keynote speaker, Rev. Jeff Crook, pastor of Black-shear Place Baptist Church in Flowery Branch, GA.

Crook preached from 1 Kings 17 on the topic of trusting in God.

The Convention Praise Team led worship with *Great Is Thy Faithfulness* and *Amazing Grace My Chains Are Gone*.

President Mark Becton gave announcements, and the session was closed in prayer.

### Monday, Nov. 8, 2010 Evening Session

Brandon Pickett welcomed Leo Day, who sang *His Faithfulness*

and *I Stand*.

Rev. Randy Green, pastor of Harvest Fellowship Baptist Church in Smithfield and SBCV 1<sup>st</sup> vice president, welcomed the evening guests and introduced Rev. John Koch, pastor of Three Rivers Community Church in West Point, who opened the session in prayer.

Rev. David Bounds, interim church health strategist for the Southeast Region, introduced Rev. Tim Piland, pastor of Nansemond River Baptist Church in Suffolk, to give the theme challenge for the evening. Piland spoke from Luke 5:12 on the greatest challenge we face—to introduce all of the world to Jesus.

The Convention Praised Team led in worship.

Jeff Ginn gave an overview of the life of Sue Sawyer, who will be retiring as Women’s Ministry strategist at the end of the year after 12 faithful years of service.

Doyle and Sharon Chauncey presented Sue with flowers and a plaque and prayed over her.

State Missions Reports were given by Steve Bradshaw, Darrell Webb, and Jack Noble.

Noble, church health strategist for the Central-West Region, shared the story of Bob Finck’s transformed life (home church of Fellowship Community Church, Salem). Finck’s family, pastor, and friends were introduced. The transformed life of Theresa Maner was shared, and Pastor Rick Ewing and the congregation from Theresa’s home church (Pleasant View Baptist Church, Lynchburg) were asked to stand.

Steve Bradshaw encouraged pastors and churches to attend Church Health Workshops around the state.



Jeff Ginn presented the Pentecost Awards for Baptisms. Rev. Jimmie Davidson, pastor of Highlands Christian Fellowship in Abingdon (top church in total baptisms), and Rev. Tom Phelps, pastor of Discipleship Baptist Church in Buena Vista (top church in baptisms per capita), accepted the awards for their churches.

The mass choirs and Convention Praise Team, led by David Dalton (minister of music at Hyland Heights Baptist), performed *Victory in Jesus, Power in the Name*, and *Lord, You're Holy*.

Rev. Chris Gill, pastor of Reservoir Community Church in Yorktown, introduced the keynote speaker, Dr. J. D. Greear, pastor of The Summit Church in Durham, NC.

Leo Day provide special music before Greear spoke. Greear preached from John 12 with a message entitled, *The Church and the Great Commission*.

The Convention Praise Team led in a time of reflection with the song, *Take My Life and Let It Be*.

Becton made the closing announcements for the evening.

Rev. Reggie Hester, pastor of Bethel Baptist Church, Chesapeake, closed the session in prayer.

## **Tuesday, Nov. 9, 2010 Morning Session**

The Convention Praise Team led in worship with *Blessed Assurance* and *I Will Love the Lord*.

Rev. Paul Randlett, leader of the Convention Praise Team and contemporary worship leader at Hyland Heights, introduced Leo Day, who performed *He Leadeth Me*.

An SBCV 360 video highlighting several statewide events was shown.

President Mark Becton reminded attendees that God is a rewarder of those who seek Him and related that thought to a recent personal trip to Israel.

Rev. Henry Amedeker, pastor of Seed International in Richmond, opened the session in prayer.

The 768 guests and messengers were called to order by Becton, who then called Carl Weiser to the podium.

## **MOTION**

A motion was made that the convention adopt the 2011 Ministry Investment Plan that had been presented by Doyle Chauncey the previous day. It was approved unanimously with no questions.

## **RECOMMENDATIONS**

Carl Weiser presented two recommendations from the Executive Board that were distributed to the churches and posted on the SBCV website 60 days prior to this meeting, as required. The first was that messengers receive for information the proposed amendments to the constitution of the SBCV (including the additional recommended changes by the Executive Board October 5<sup>th</sup>). These were found on pages 1 – 3 in a separate handout. The attendees were referred to the handout that had been highlighted with yellow and red, indicating the changes. It was explained that these changes would be voted on at the 2011 Annual Homecoming. One question was asked concerning the change about employed staff having to sign and support the statement of doctrinal affinity. Weiser addressed the question, saying that the section had been moved from the constitution to

the bylaws. Weiser also presented the Executive Board's recommendation concerning the articles of incorporation and the bylaws. These proposed changes were found on the same handout. A call for questions came with none noted. The recommendation passed unanimously.

Rev. Paul Davis Jr., chairman of the Resolutions Committee, was called to the stage to present the proposed resolutions. Davis read the following resolutions, which were also shown on the screens:

## **Resolution 1**

"Be it resolved that the churches of the SBCV and across the Southern Baptist Convention be encouraged to give at least 10% of their offerings to the Cooperative Program for the furtherance of God's Kingdom upon the face of the earth."

A call for questions came with no response. The resolution passed unanimously.

## **Resolution 2**

Whereas, the SBCV fully embraces and affirms the Great Commission Resurgence in the S.B.C.

Whereas, the SBCV recognizes the urgency of fulfilling the Great Commission.

Therefore, Be it resolved the messengers of the SBCV challenge the SBCV churches to increase their Cooperative Program giving by .25% yearly until 2020.

A call for questions came with no response. The resolution passed unanimously.



### Resolution 3

Whereas, the messengers of the Annual Homecoming 2010 of the Southern Baptist Conservatives of Virginia have enjoyed a time of encouragement, worship, unity, and the Spirit's direction; and

Whereas, we acknowledge the Lord's providence for all these blessings and

Whereas, we acknowledge the hospitality of the people of Lynchburg, Virginia, and

Whereas, we acknowledge the Kingdom-focused work of Pastor Carl Weiser and of the people of Hyland Heights Baptist Church of Lynchburg, VA, who worked diligently to bless us with kindness and service, and

Whereas, we acknowledge the extraordinary commitment, extensive labor, and excellent leadership of the Southern Baptist Conservatives of Virginia Executive Director and Treasurer Dr. Jeffery B. Ginn, and

Whereas, we also acknowledge the Lord working through our officers, various committees, speakers, musicians, and other platform personnel to guide the affairs of this convention with a Christ-like spirit, professionalism, and common vision.

Rev. Ron Kidd, church planting strategist for the Central-East Region, introduced and prayed over Dr. Brian Autry, pastor of Parkway Baptist Church in Moseley.

Autry gave a theme challenge from the book of Job entitled, *The Greatest Information We Have to Share*.

Leo Day sang *Give Me Jesus*.

2010 report from the Mobilizing Churches Committee. He highlighted English as a Second Language (ESL), Missions Service Corps, Baptist Builders, and Buckets of Hope.

An SBCV 360 video was shown that highlighted the Buckets of Hope ministry.

Ms. Sue Sawyer, associate church mobilization strategist for projects, spoke regarding the 2010 Hands-on Mission Projects efforts.

Mr. Eddie Urbine, associate church mobilization strategist for partnerships, addressed the convention regarding partnerships with the Dakotas, Uruguay, and Africa.

Gauthier explained how the Act 1:8 Network will enable churches to partner together to minister in Vietnam, North Africa, Nicaragua, Burkina Faso, Peru, Haiti, and other countries. He encouraged churches to join the network.

Becton introduced the following SBC partners, who shared their reports: International Mission Board (Ron [for security reasons, his last name was not given]), North American Mission Board (Dr. Harry Lewis) and the SBC Executive Committee (Dr. Roger Oldham).

Rev. Larry Black, church planting strategist for the Central-West Region, introduced and prayed over the keynote speaker, Dr. Bobby Welch, strategist for global evangelical relations for the SBC.

### **SBCV Affiliate Directors and Managers**

### **Innovative Faith Resources**

Named “SBCV Financial Services” when it was formed in 1999; renamed “Church Ministry Services” in 2006; and renamed “Innovative Faith Resources” in 2011, Innovative Faith Resources (IFR) is a wholly owned affiliate of the SBCV. Its original purpose remains to assist SBCV churches less than five years old with short-term loans that would serve as a bridge to obtaining long-term financing from the North American Mission Board or other financial lending institutions. The Executive Board in its May 2006 meeting expanded this ministry by authorizing the corporation to begin providing low-cost payroll, legal and risk-management referrals, and accounting services for churches. We are presently providing services for more than 50 church plants and existing churches. In their meeting October 10, 2011, the directors of IFR affirmed the name change and Business Plan and approved a Master Service Agreement between SBCV and IFR. They also amended the Bylaws to include providing media services for SBCV, churches, state conventions, and associations; SBC and other denominations; non-profit organizations; and limited services of “for-profits.” At the SBCV Executive Board meeting on October 11, 2011, the board

affirmed the actions taken by the IFR directors.

### **Cooperative Program Update**

We have received \$6,465,342 in Cooperative Program contributions from SBCV-affiliated churches and individuals during the first three quarters of 2011, compared to \$6,446,801 or 0.3% more than for the same period last year, and -4.2% below budget. However, a comparison of the last 12 months (October 1, 2010 through September 30, 2011, \$8,621,760) with the previous 12 months (October 1, 2009 through September 30, 2010, \$8,896,573) shows a net decrease of \$274,813 or a -3.2% decrease. Our prayer is that the downward giving trend will not continue and that CP contributions in the churches and to the state convention will return to the historic giving levels prior to the 2008 economic financial crisis. We remain optimistic and trust that God will provide the resources needed to advance His work in Virginia and beyond.

### **Proposed Ministry Investment Plan**

The Proposed Ministry Investment Plan for 2012 in the amount of \$9,000,000 is to be funded by undesignated Cooperative Program contributions from the churches. The 2012 plan is the same as last year's ministry plan. By the end of this year, 2011 Cooperative Program contributions are projected to be approximately \$9,000,000, which will fully fund the ministry plan. Footnotes to the Proposed 2012 Ministry Investment Plan will provide additional information and help explain a recent paradigm shift at the national and state convention levels regarding promoting, processing, and funding Cooperative Program and stewardship. Almost every state convention is facing major funding and organizational challenges as a result of actions taken by the Executive Committee of the Southern Baptist Convention.

### **Q&A Breakout Regarding Proposed Ministry Investment Plan:**

Following adjournment of the Monday afternoon session at

4:45 PM, I will be available in room 105 to answer questions and provide additional information concerning the Proposed 2012 Ministry Investment Plan. We will discuss the paradigm shift and the changes that have taken place as a result of the Southern Baptist Convention Executive Committee's decision to give the responsibility for Cooperative Program and stewardship promotion back to state conventions.

God has given us a great strategy to spread the Light of the World, Jesus Christ. In Acts 1:8, as Jesus was approaching His ascension, He gave the Church a battle strategy. The Church would move out in concentric circles, starting in Jerusalem, then to Judea and Samaria, and then to the ends of the earth. ## Maturing Churches Take New Steps with Vision 20/20 in Sight

Even with the recent departure of the executive director of the SBC of Virginia, the Maturing Churches Team still has its eyes on the goal of Vision 2020. As a matter of

fact, in a spring retreat setting, new strategies were laid out that should prove beneficial to existing churches in their task of fulfilling the Great Commission.

With the overall theme for 2012 being *Transforming Churches*, the Maturing Team will focus on three E's: *Evaluating, Equipping, and Evangelism.*

## 1. Evaluate.

The church health strategists stand ready to conduct Church Health Workshops in each region. By using LifeWay's *Transformational Churches* resources, 120 churches have already begun the process of discovering their current condition and are implementing strategies that can lead them to the next level of church health, growth, and vitality. As *Transformational Church* consultants, the CHS's have assisted churches in interpreting the results of their survey assessment and have conducted customized retreats that lead to setting priorities and action plans.

## 2. Equip.

### E412 Statewide Equipping Conference

For the past two years, SBCV has provided one statewide event to train all church leaders. This year was no exception, as we held E412 at Liberty Baptist Church in Hampton, April 8–9. While 41 attended the Church Planter Network, 66 participated in Disaster Relief training, and 181 were equipped for this year's Vacation Bible School. Additional church leaders numbering 256 were trained in finance, budgeting, legal matters, multi-siting, church staff, conflict resolution, music



and worship, media, Women's Ministry, Men's Ministry, missions, small groups, Sunday School, discipleship, youth, children, and preschool. Everyone was encouraged and challenged by the preaching of James Merritt and Brian Bloye and blessed by the music ministry of the host church.

### **E412 Regional Equipping Conferences**

Each region is comprised of church staff and leaders who are experts in their field of ministry. The field missionaries are in the process of enlisting and equipping those local experts to be a part of **Regional Ministry Assist Teams**. For instance, if you have a Women's Ministry need or a Sunday School need, will have a go-to person near your church. With these great leaders and resources in each region, instead of traveling to a state leadership conference, you will have the advantage of equipping your church leaders in your immediate area. These equipping conferences will be held on September 8 and 15, 2012.

### **Pastor and Staff Fellowships – Connections Go on Tour:**

Pastors and ministerial staff not only enjoy fellowship with others who share the same vocational calling, but they pray and encourage one another in ministry. In September, the Connections took a different twist. The meetings went on tour—on location at some strategic churches of all sizes and styles in each region. While on site, there was a fellowship meal, a tour of the facilities, and a time to glean from the staff and/or lay leaders on how they do effective ministry. They highlighted aspects of ministry such as: first impressions, greetings, follow-up strategies, media communication, assimilation, small group Bible

studies, worship teams and preparation, promo of offerings and CP, missions strategy, evangelism and outreach strategies, and specialized ministries like women, men, youth, children, etc.

### **Power Meals Continue to Be a Great Source of Small Group Fellowship**

The restaurant is the gathering place for pastors and staff. The food is delicious, the fellowship sweet, the sharing open, the resources beneficial, and the time well spent.

### **Ministers' Wives (SWAT) One-Day Conferences**

Nearly 80 ministers' wives took advantage of the two simultaneous one-day conferences held at Staples Mill Road Baptist Church, Glen Allen and Green Ridge Baptist Church, Roanoke. Shari Falwell and Cathy Early were the keynote speakers, encouraging wives to open, embrace, and celebrate God's gifts. Special music, applicable breakouts, and lunch were provided.

### **Pastors' Conferences: Refuel: Innovate Church**

Thomas Road Baptist Church in Lynchburg was the host church for the annual ministers' conference called Refuel. This year's keynote speakers included: Jonathan Falwell, John Maxwell, Steven Furtick, Johnny Hunt, Jud Wilhite, Ed Stetzer, and Tom Mullins. Special music was provided by Charles Billingsley. Shari Falwell hosted a breakout for ministers' wives.

### **Pastors' Conference: Vantage Point & Star City Bible Conference**

First Baptist Church, Roanoke was the host church for the

annual Vantage Point and Star City Bible Conference. Guest speakers included: James Merritt, Mac Brunson, Jonathan Falwell, Fred Wolfe, and Ronnie Floyd. Special music was provided by Charles Billingsley and The Sounds of Liberty.

### **Cooperative Program Resources**

In partnership with the Southern Baptist Convention's Executive Committee and in agreement with the Great Commission Resurgence action taken at the 2010 Southern Baptist Convention, the SBCV has invested in and is providing Cooperative Program resources to its churches. The familiar **Missionary Moments** prayer guide was provided in 2011 along with a DVD that puts a name and face with the prayer needs of SBC missionaries. **The Gift** was also a great tool to explain step by step how a church tithe reaches the mission field of the state, continent, and the world. In partnership with the Executive Committee and sister state conventions, the SBCV Media Team has produced **Cooperative Program videos** that are relevant and connect with congregations.

## **3. Evangelize.**

### **God's Plan for Sharing**

Churches have been encouraged to participate in the North American Mission Board's initiative called GPS (God's Plan for Sharing). GPS takes place through the course of several weeks leading up to and following Easter. Prayerwalking, Gospel distribution, invitations to special Easter services, and follow-up are all components emphasized again this year. Several additional churches have

committed to participate in GPS activities, bringing the total to 210. In 2012, the GPS emphasis will be on attractional events.

### **Find it Here.com Race at South Boston**

In 2011, the Central-West Region piloted a **FindItHere.com Race** at the South Boston Raceway, where 11 churches partnered together for this GPS attractional event. These churches hosted block parties, gave away water and funnel cakes, and shared the Gospel as people registered to win a flat screen TV. Two young girls prayed to receive Christ while at the event. Churches will also follow up on prospects and encourage those who respond to the 1-800 number. There are raceways in every region, and this opportunity is a possibility for networking churches in 2012—or churches can use an existing event and make it more intentionally evangelistic.

### **Vacation Bible School Still the Greatest Evangelism Event**

This year, the SBCV enlisted two state VBS teams to train church leaders at six Super VBS Clinics across the state. In addition to the E412 location, there were clinics held in each region. Training was provided for directors, pastors, children, preschool, Bible study, missions, music, crafts, recreation, snacks, and special needs. There were over 500 in attendance. In 2012, there will be 12 VBS Clinics that will focus on teaching tools for children. They will feature both LifeWay curriculums and an addition for this year—overviews of Standard and Group curriculums.

### **Serve Your Community Day**

SBCV churches were encouraged to participate in the annual

convention-wide **Serve Your Community Day** on July 17.

### **Every Believer a Witness**

The **Every Believer a Witness** resource and training addresses the four major reasons most Christians aren't sharing the Good News. It does so in a new way and with unheard-of results. SBCV churches will have access to this tool and training to help believers overcome apathy, ignorance, fear, and powerlessness.

### **Block Party and Sports Trailers Remain an Effective Evangelistic Tool**

The Block Party Trailer Ministry continued to grow this summer with 7 interns staffing 5 block party trailers and 2 sports trailers across the Commonwealth. There were 25 assisted block parties with 8,721 in attendance and 46 decisions for Christ. Through the use of the trailers, church members are involved in direct evangelism, hands-on ministry, and follow-up. At one block party alone, a church gave away 435 backpacks, 78 free haircuts, over 800 hotdogs, and 100 Bibles...and the Gospel was presented numerous times.

## **Other Ministries:**

### **STUDENTS:**

#### **YEC Reaches New Milestone: Over 2,000 in Attendance**

The annual Youth Evangelism Conference drew a record attendance at London Bridge Baptist Church on the weekend of January 14 – 15. The worship center was packed with 2,017 to hear Tenth Avenue North lead worship, Darren Whitehead proclaim the Gospel, and Brock Gill amaze them with illusions. The

near-capacity crowd has led to pre-reservations for 2012 with 1,000 already committing to attend.

### **Student Pastor Retreat, SAT, and Regional Networks**

Student pastors have many opportunities throughout the year to network and glean from one another's ministries. The annual Student Pastor Retreat for the entire family was held on February 18 – 19 at Great Wolf Lodge in Williamsburg with over 150 in attendance. The Student Advisory Team (SAT), comprised of key student pastors from across the state, meet semiannually to assist in planning, coordinating, and evaluating ministry to students. Student pastors also network regionally for food, coffee, and fellowship on a regular basis.

### **25 SBCV Churches Awarded Summer Intern Scholarships**

One way to extend the ministry of the local church and church staff while also mentoring and investing in future church leaders is through summer internships. In 2011, through the Vision Virginia State Missions Offering, the SBCV was able to award scholarships to 25 churches. The scholarships were for a maximum of \$1,500 for a 10-week period. The churches each provided an additional \$1,000 for the same period. In addition to their church responsibilities, the interns attended a pre-summer training and assisted as staffers at SBCV Studentz Camp.

### **Studentz Camp Reaches a Record 1,600**

Studentz Camp almost doubled in attendance from a year ago. With the additional **Camp for an Evening** attendees on Wednesday, a record 1,600 had the privilege of hearing Tony Nolan (speaker), Andy Kirk (worship),

HarrisIII (illusionist), and Barlow Girl (concert) point students to Christ in a compelling way. This year's camp featured a competition component. Students were given points for Scriptures quoted, having team spirit, competing in recreation, etc. At the end of the week, a total of 287 complete chapters and 10,000 individual Scripture verses had been recited by the students. Some churches opted to participate in the annual Missions Track, where students leave the campus for a portion of each day to engage the area's mission field and experience first-hand church planting activities. This year, there were 17 participating churches with 354 students and leaders, contributing 1,416 hours of mission service to 3 communities. There will be a new church start as a result of this year's Missions Track. Students' lives are changed at camp, and they are joining the Lord in His work of bringing about transformation to the community. This year's SBCV camp received the top national media award for its theme graphic. Studentz Camp is becoming one of the largest camps in the country, and it strives to be the best camp as it honors and points students to Christ. Be watchful and prayerful as Studentz Camp expands and broadens its borders and extends its reach in 2012 and beyond.

## **WOMEN:**

### **New Women's Ministry Strategist Hired**

Tammy Bennett has been hired as the second SBCV Women's Ministry strategist. She began the part-time position effective April 1. Tammy has a wealth of experience in her background—professional acting; production and development research for a national Christian TV show;

authoring two books under the Harvest House Publishing Company label; authoring three books under the Baker Publishing Group label; and authoring numerous magazine and blog articles for HomeLife magazine, Crosswalk.com, Journey devotional magazine, and Insight magazine. She has been a motivational speaker at women's events and an instructor of Upper Class, a division of CLASServices, where she taught women effective non-verbal communication skills. She has been a senior writer and guest host for a Christian Women's TV show, "Living the Life," with CBN. In developing young women, her passion has been reaching girls and teens through AWANA and expanding that ministry to the 20-something generation. She is also involved in the National Religious Broadcasters organization, where she has assisted in coordinating its convention of over 6,000 people. She has been a Women's Ministry coordinator at her church, served as Women's Ministry Committee chair for the Marine Corps Air Ground Combat Chaplaincy Ministry, and has developed, written, and taught conversational English for the Chinese. She has also been on numerous mission trips within the US and abroad.

Tammy studied environmental and interior design at the University of California at Santa Barbara. She also has certifications in personality profiling, motivational speaking, media insights, and teen and youth missionary training. Because of her husband's military career, Tammy and her family have lived throughout the country, making three Virginia cities home and three SBCV churches their extended family—London Bridge Baptist Church, Spotswood Baptist Church and now, Grove Avenue

Baptist Church. Tammy and her husband Ed have two grown children, Matthew and Ashlee.

### **Going Beyond Conference with Priscilla Shirer**

In Partnership with LifeWay and Thomas Road Baptist Church, over 2,500 women convened in Lynchburg on April 15 and 16 to hear the encouraging words, "God wants to meet you where you are" from Priscilla Shirer. Tony Evans provided special music for the weekend.

### **Regional Women's Ministry Assist Team led the way for Regional Conferences**

The face of SBCV Women's Ministry is changing. Not only because it has a new leader, but because there are now five new faces that represent Women's Ministry in each region. Sylvia Frejd of Spotswood Baptist Church, Fredericksburg, serves in the North Region. Tammy Bennett of Grove Avenue Baptist Church, Richmond serves in the Central-East Region. Teena Paxton of Rosedale Baptist Church, Abingdon serves in the Southwest Region. Teresa Sours of Wayne Hills Baptist Church, Waynesboro serves in the Central-West Region, and Sandy Ford of Ebenezer Baptist Church, Gloucester serves in the Southeast Region. Considering the size of the state and the number of churches that comprise the SBCV, these ladies will make it possible for your church to readily access their knowledge, training, and resources. They will assist with the regional E412 equipping conferences, state women's conferences, and regional women's conferences. As they serve out of a selfless heart, their desire is to see Women's Ministries flourish throughout Virginia and beyond.

Their shared goal is simple: “We collectively desire to exemplify the Titus 2 model—women of all ages mentoring women of all ages.”

## **MEN:**

### ***Courageous* Movie Leads to Evangelism and Outreach Strategies**

From the makers of the movie *Fireproof*, the release of *Courageous* took place on September 30. In partnership with Sherwood Baptist Church, Provident Pictures, and LifeWay, the SBCV co-hosted movie previews in May at eight churches. Pastors and church staff had an opportunity to view the movie and consider strategies for evangelism and outreach and anticipate how it would impact men in relationship to their wives and children.

### **Wildfire Men’s Conference Moved to November**

The annual men’s conference was held again this year at Thomas Road Baptist Church, Lynchburg on November 11 & 12. Keynote speakers were Randall Cunningham, Ernie Irvan, Keni Thomas, Brad Stine, Miles McPherson, Tim Clinton, and Jonathan Falwell. Special guests included Brock Ray and Bob Dees. There were also exhibits, demonstrations, and breakout sessions that addressed men’s needs and interests.

The SBCV continues moving towards becoming “a mobilizing missional network . . . in which the number of congregations committed to the Acts 1:8 Challenge grows to over 500 by 2020.” To assist more SBCV churches in developing an Acts 1:8 strategy, we have begun the process of engaging Mission Service Corps (MSC) volunteers through the North American Mission Board (NAMB). Five positions have been identified, job descriptions developed, and positions posted on the NAMB MSC website.

### **Acts 1:8 Network**

Networks have been established that will enable SBCV churches to work together, duplicating what many churches are already doing: reaching Jerusalem, Judea, Samaria, and the ends of the earth with the Gospel. Churches will be able to work together as partners to pray, give, do, and go in each of the many network focuses. These will include international as well as North American opportunities. Current networks include:

*Nicaragua*  
*North Africa*  
*West Africa*  
*Sub-Saharan Africa*  
*Pacific Rim*  
*Southeast Asia*  
*Dakotas*

...with more to come!

Churches are on mission all around the world. Many of them are ministering in the same regions and reaching similar people, but most aren't aware of all of the other churches who might be working nearby. Wouldn't it be great if they all had an easy way to find each other and connect?

Through the Acts 1:8 Network, churches can learn about what other churches feel the Lord's calling to reach their target people groups. They can meet each other, pray for each other, and pool their experience and resources for greater Kingdom impact. The overarching goal is to connect churches from across the state that have a calling to reach the same nation or people group to work together.

For example...

Perhaps you're engaged in Nicaragua. Are you aware that there are 10 or 12 other SBC of Virginia churches that also have works in Nicaragua?

Through the Nicaragua Network, you'll be able to share successes, opportunities for improvement, prayer requests, and other needs with these churches. You might even be able to coordinate and serve with them in joint efforts.

In 2011, more than 35 churches have enrolled as Acts 1:8 Network churches, bringing the total to just over 115 churches.

### **Disaster Relief Ministry**

The Disaster Relief Ministry continues to break new ground. This fall, more than 325 newly trained volunteers, all students from Liberty University, were deployed in a first-of-its-kind mobilization of students for Disaster Relief. These students were trained and mobilized in less than two weeks, working

in homes flooded by Hurricane Irene and Tropical Storm Lee in New York and Vermont. These new volunteers are in addition to the nearly 200 other newly trained workers that attended the regular spring training sessions across Virginia. This year, DR volunteers have responded to disasters in New York, Vermont, and Pennsylvania as a result of Irene/Lee, the tornados across Virginia in April, and the spring floods in Vermont. In all, more than 500 volunteers responded as part of feeding, chainsaw, flood recovery, assessment, and incident command teams.

### **Baptist Builders**

Baptist Builders continues to grow with more than 550 active volunteers. They have participated in four projects (mobilizing more than 10 teams) this year. For the first time, Baptist Builders were involved in the building of a steel frame structure from the ground up! Multiple teams responded to Good Shepherd Baptist Church in Christiansburg over a five-week period. The teams began by assisting in preparing the foundation and continued until the 26,000-square-foot building had the frame and roof in place. Additional projects took place at Preston Oaks, Mountain View, and Cornerstone Baptist Churches, involving hundreds of volunteers who provided critical labor to complete the projects.

### **Families on Mission**

Families on Mission (FOM) was hosted by Oak Grove and East Stone Gap Baptist Churches in Big Stone Gap, VA. The Families on Mission program is sponsored by the SBC of Virginia and is essentially a turnkey mission opportunity for our families to

serve together. This gives parents or grandparents the chance to model missions and evangelism to their children and grandchildren, as young as five years old. Children ministered alongside family members as they met the physical and spiritual needs of the community. The event drew 72 participants from across Virginia. FOM for 2012 will be in the community of Bluefield, VA and registration is now open with families already signing up.

### **Mission Service Corps**

Mission Service Corps (MSC) are self-funded missionaries who serve for two years or more. They provide their own financial support in an assigned ministry that assists the evangelism and church planting efforts of NAMB and its mission partners. The placement comes through the Mission Service Corps office of NAMB. SBCV currently has one MSC position filled—that of recruiter/trainer—and is actively seeking additional MSC missionaries to fill various Mobilizing Churches positions.

### **VA Soldier R&R Kits**

Once again, this mission opportunity was a huge success. More than 1,250 kits were collected from 57 SBCV churches providing DVDs, snacks, devotional guides, tracts, and notes of encouragement to our Virginia soldiers serving in Afghanistan. SBCV churches have sent over 5,000 kits over the past four years.

### **Blankets for Childcare Disaster Relief Trailers**

Incredible! That's just one word to describe the overwhelming response from SBCV churches for this first-time project. Over 3,000 blankets were received and are now in locations around the Commonwealth to minister to those hurting from disasters. Our SBCV childcare Disaster Relief trailer will distribute blankets to help comfort children whose families have experienced some type of disaster.

### **Southern Cross Bible Distribution**

Each year, more than one million Han Chinese visit Southeast Asia, where volunteer teams are able to legally distribute Bibles and religious materials. SBCV churches contributed monies to put over 14,000 Bibles in the hands of those who need the Good News!

### **Back-to-School Backpacks for DC Children**

God continues to work through SBCV church planters to reach families in Washington, DC. Even though this is the capital of our nation and there are many affluent people living in the area, there are also large numbers of families living in poverty. Through SBCV churches, over 350 backpacks were filled with school supplies and distributed to needy children in the DC area.

### **Hygiene Kits for ARM**

Central Appalachia has been described as the "poverty pocket of America" and includes 37% of the 100 poorest counties in the US. During August and September, SBCV churches collected hundreds of hygiene kits and shipped them to Appalachian Regional Ministry headquarters in Hurricane, WV. Adults and children can practice

better hygiene because you cared enough to assemble a hygiene kit for them.

### **Eyeglasses for Uruguay**

As we continue our partnership with the International Mission Board (IMB) in Uruguay, we helped supply medical clinics with eyeglasses in October and November. The need for glasses is great, and most people in Uruguay cannot afford them. The hundreds of pairs of eyeglasses that were collected by SBCV churches will be distributed by local missionaries in Uruguay and will open doors for them to share the Gospel.

### **English as a Second Language (ESL)**

Our culture is changing rapidly, and God is opening the doors wide for a much-needed area of ministry—teaching English as a Second Language (ESL). SBCV is beginning to strategize as to the most effective way to offer leadership in this area of ministry and to encourage SBCV churches to participate. Numerous training opportunities were provided during 2011. In the near future, we desire to have an ESL strategist in each ministry region to offer training and networking opportunities for churches in that region and a statewide ESL strategist to give guidance to the regional strategists.

### **Food Distribution Ministries**

As our economy continues in a downturn and many individuals are without jobs, the demands on SBCV churches offering Food Distribution Ministries are great. With the help of NAMB World Hunger Funds and funds given by SBCV churches to our the Vision Virginia State Missions Offering, there are six SBCV churches with very active Food Distribution Ministries. So far this year, these churches have

recorded 16 salvations, over 2,000 evangelistic encounters, over 4,000 hot meals served, and over 12,000 individuals helped with grocery items. All SBCV churches have made this possible as you have given through the Cooperative Program and the SBCV Vision Virginia State Missions Offering.

## **Mission Partnerships**

### **Eddie Urbine Church Mobilization Strategist, Partnerships**

Partnership opportunities are continuing to be developed in concert with the IMB's model of reaching people groups and engaging them for multiple years. We are continuing to model mission trips as small teams of two to six people going to engage the same people group multiple times during the year versus a large once-a-year trip.

During the past year, the SBCV has sponsored two international vision trips—one to Uruguay and the other to the Kingdom-to-Kingdom cluster in South Africa and Botswana. Four churches took the challenge to envision God's work to be done in Uruguay with former SBCV missionary, Tony Inmon. The local churches have already planned two follow-up trips to Uruguay for 2012.

Two churches connected with the vision trip to South Africa and Botswana. During this trip, Bermuda Baptist began the first steps to engage the unreached Pedi people. They have since returned to the Pedi and have developed a strategy for reaching this unreached people group for Christ. The other church is in the planning process to return to South Africa.

In partnership with the IMB, the SBCV has begun to challenge our

churches to “embrace” unreached people groups across the world. By embracing a people group, the local church undertakes the challenge to begin to intentionally reach the people group with the Gospel. For more information, visit [www.call2embrace.org](http://www.call2embrace.org)

During 2012, the SBCV will be leading a vision trip to Botswana. This trip will be geared for churches that have little or no international experience in missions. We are also taking the first steps toward a new partnership with the New England Baptist Convention. All of our work in partnerships is geared toward connecting our churches to the Acts 1:8 Networks so that they can work together with other local churches to reach the lost for Christ.





# *Multiplying Churches Report* *2011*

The Multiplying Churches Team exists for the purpose of assisting our member churches in fulfilling the Great Commission by way of planting new churches among all peoples throughout Virginia and

Washington, DC. At a time when we have more lostness in Virginia than ever before, and in a time when we are trusting the Father for the privilege of partnering with our member churches to initiate 400 new churches before the end of this decade—we are all eager to see increasing numbers of church planting candidates approved and placed in the field. In equal measure, we are also trusting the Father for increasing numbers of churches directly involved in sponsoring new churches.

In order to keep pace with the visionary goal of planting 400 churches in 10 years, there needs to be an average of 40 church planters assessed, equipped, and deployed annually. The fact that there were not more candidates approved in 2011 is not a result of poor performance on the part of

your SBCV church planting strategists. Instead, it was due to an effort on our part to live within the means of mission dollars available for supporting newly approved planters. Furthermore, moving into the new home for the Glen Allen Mission Support Center in October has immediately resulted in significant monthly savings—enough to partner with sponsoring churches to place one new planter on the field every month over and above our current capacity.

With the current reality of curtailing our efforts in church planter enlistment over the last two years, SBCV church planting strategists have spent even more time in mentoring and coaching the planters that are already at work in starting new churches. Such efforts have partially contributed to the following growth trends among our church plants as reported in the 2010 Annual Church Profile (ACP).

Of the 60 church plants reporting:

**397 baptisms** in 2010 (up from 328 in 2009: +69)

**4,703 weekly worshippers** in 2010 (up from 3,658 in 2009: +1,045)

**\$280,683 in Cooperative Program Giving** for 2010 (up from \$211,957 in 2009: +\$68,726)

Since the 2010 SBCV Annual Homecoming, 9 church planters and 7 church planter apprentices have been approved. Currently, 49 out of 570 SBCV churches (or 8.6%) contribute to church planting support over and above their Cooperative Program giving.

A well-balanced church planting strategy includes not only the placement of funded church planting teams, but also a host of non-funded church planting teams

as well. There are not enough Cooperative Program dollars in existence to place all of the church planters needed as quickly as they are needed to reach the swelling numbers of people around us who do not have the hope of salvation in Christ. To that end, the Multiplying Churches Team has worked this year to create a new resource to assist our churches to increase their evangelistic footprint, which will, in part, lead to an increase of newly planted churches led by everyday believers. The Communities of Hope initiative and its resources will be unveiled to our churches this year at the Annual Homecoming in Richmond.

2011 has also been a year for giving back. Now in its sixth year, Lifepoint Church in Fredericksburg has grown from an initial group of 50 to more than 1,500 weekly worshippers. In August, Lifepoint mobilized 200 of its ministry volunteers and spent \$27,000 to host a group of 450 church planters and team members for REACH. REACH was an opportunity for church planting teams to see and experience firsthand all of the systems used by this dynamic plant still meeting in a portable setting. Planters and team members left affirmed and excited, having seen full-scale expressions of the very same systems they are using in the earlier stages of church planting. SBCV planters and team members at REACH numbered 180.

Another way that planters have given back in 2011 is in the creation of a new training resource. Led by former SBCV church planter and author Ben Arment, 10 SBCV church planters who have established healthy growing churches have written the next-generation church planting training manual, which is still in development. Once complete, this

resource will be used to train the next generation of church planters in Virginia, Washington, DC, and beyond.

Finally in 2011, we now have a comprehensive strategy for assisting the SBCV and the SBC in evangelizing our nation's capital, largely by way of church planting. For the past two years, Dr. Joe Hernandez has been living and working part-time in the DC Mission Center—a ministry location made possible by the Vision Virginia State Missions Offering. Joe gained valuable first-hand perspective about the needs of the city and about other Kingdom partners with whom we can potentially partner. We are prayerful that the work of previous and current SBCV church planters in Metropolitan DC, combined with the strategy planning of Joe Hernandez and Bill Wennersten (church planting strategist, North Region), will pave the way for SBCV churches to more fully engage this needy area with the Gospel.

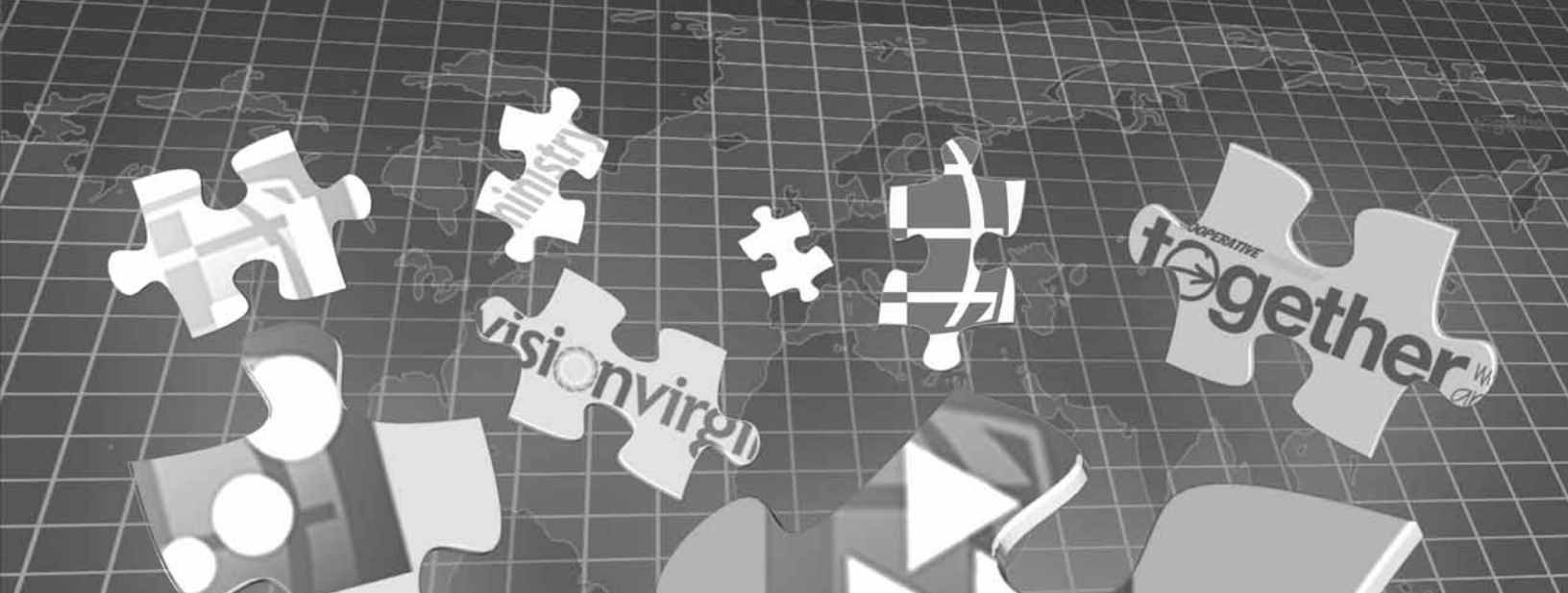

### Footnotes to the Proposed 2012 Ministry Investment Plan

- The proposed \$9,000,000 Cooperative Program Ministry Investment Plan (MIP) for 2012 is the same amount as the 2011 MIP, and Cooperative Program (CP) contributions for this year are projected to equal or exceed the 2011 \$9,000,000 goal by year-end.
- \$4,567,500 or 50.75% of all undesignated CP is allocated for Southern Baptist Convention causes.
- The proposed 2012 MIP reflects a 0.25% increase in the percentage of undesignated Cooperative Program contributions allocated for Southern Baptist Convention causes and a corresponding decrease in funds allocated for the SBCV in accordance with the Vision 20/20 strategy adopted in 2009 to increase the SBC percentage amount 0.25% every year when funds are available.
- A major shift has occurred throughout the Southern Baptist Convention that significantly impacts almost every state convention, including the SBCV. The Great Commission Resurgence (GCR) Task Force report was

- approved by the messengers meeting in the Southern Baptist Convention in Phoenix, AZ. Their recommendation resulted in a major change in the way CP is promoted, processed, and funded.
5. It was the recommendation of the GCR Task Force and the decision of the Executive Committee of the Southern Baptist Convention to dismiss all CP promotion staff at the national level and assign the responsibility to the state conventions. In return, the states will be compensated in a way consistent with the historic practice when the Cooperative Program first began in 1925.
  6. Historically, expenses incurred by state conventions for promoting and processing CP were taken out of Cooperative Program contributions to reimburse the states for assuming and fulfilling the assigned responsibility.
  7. It is estimated that in 2012 there will be \$560,698 in expenses directly associated with and incurred by the SBCV in promoting and processing CP. As recommended by the GCR Task Force, approved by the SBC Executive Committee and the SBCV Executive Board, the SBCV will follow the historic practice of retaining promotion and processing expenses from CP receipts. \$4,006,802 will be forwarded to the Southern Baptist Convention for SBC missions and ministries.
  8. The funds (\$560,698), provided by the Executive Committee of the Southern Baptist Convention, will be reallocated and used primarily for starting new churches and funding other strategic ministry opportunities in Virginia.
  9. Fifty and three-fourths percent (50.75%) of Cooperative Program funds received in excess of \$9,000,000 in 2012 will be forwarded to the Southern Baptist Convention.
  10. Any unexpended SBCV funds will be carried forward for future church planting and other strategic ministry opportunities.
  11. It should be noted that the current economic reality of diminishing resources has been brought on by a convergence of factors—a “perfect storm” sort of analogy. The major components of this storm are: plateaued and declining Cooperative Program receipts; a reduction in mission resources from the North American Mission Board; and, a significant decline in income from investments.

### **Recommendation**

The Executive Board recommends to messengers in the 2011 Annual Homecoming that the Proposed 2012 Cooperative Program Ministry Investment Plan in the amount of \$9,000,000 be adopted.





# *Proposed Changes to Constitution & Bylaws*

## CONSTITUTION

Southern Baptist Conservatives of Virginia

Adopted November 2003

- Proposed changes were presented to the 2010 Annual Homecoming messengers.
- Messengers will vote on changes at the 2011 Annual Homecoming.

### ARTICLE I – NAME

The name of this organization shall be Southern Baptist Conservatives of Virginia, hereinafter sometimes referred to as SBCV *or SBC of Virginia*.

### ARTICLE II – PURPOSE

As an autonomous state convention cooperating with the Southern Baptist Convention, the SBCV is a fellowship of Southern Baptist Convention churches cooperating to assist local congregations in their task of fulfilling the Great Commission as commanded by our Lord Jesus Christ.

### ARTICLE III – DOCTRINAL POSITION

We believe that the Bible is the verbally inspired Word of God, wholly without error as originally given by God, and is sufficient as our only infallible rule of faith and practice. We deny that other books are inspired by God in the same way as the Bible. The fundamental truths to which we are committed are expressed in *The Baptist Faith and Message*, 2000 with the clarification of inerrancy as described above. The doctrinal position of the Southern Baptist Conservatives of Virginia shall not be binding upon any local church; however, the ~~Convention~~ **SBCV** recognizes its right and responsibility to determine its identity, including doctrinal parameters, and to include within its affiliation those churches who can freely agree with it, and to exclude those churches ~~who~~ **that** do not. ~~All employed staff of the Southern Baptist Conservatives of Virginia are expected to agree with and fully support the body's doctrinal position and shall complete a signed statement of doctrinal affinity. Failure to demonstrate concurrence with the doctrinal stance of the Southern Baptist Conservatives of Virginia shall be sufficient reason for termination of employment of any employee of the Southern Baptist Conservatives of Virginia.~~

### ARTICLE IV – RELATIONSHIPS

While autonomous in its own affairs, Southern Baptist Conservatives of Virginia, recognizing the autonomy

of other Baptist bodies, disclaims all right of exercising authority over any church, association, or convention. However, the Southern Baptist Conservatives of Virginia may rescind the affiliation of any church, which shall, in the judgment of Southern Baptist Conservatives of Virginia, depart in doctrine or practice from the affiliation qualifications set forth in the Constitution and Bylaws.

Southern Baptist Conservatives of Virginia is open to cooperation with other Christian bodies insofar as the SBCV determines that such cooperation does not compromise the doctrinal stance of the SBCV.

## ARTICLE V – AFFILIATION

- A. Affiliation Qualifications: An affiliated church must agree with the foundational beliefs of ~~this Convention~~ **the SBCV** set forth in the Constitution and Bylaws. Affiliated Churches must actively cooperate with the work of the SBCV through regular financial support **to The Cooperative Program**.
- B. Method of Church's Becoming Affiliated:
1. Any Baptist church desiring affiliation in this body shall complete an affiliation application indicating agreement with the doctrinal position of the SBCV and make an initial contribution to the SBCV. Such application must be received at the state office at least two months prior to the ~~aAnnual mMeeting~~.
  2. All churches having submitted an affiliation application shall be examined by the Executive Board (or a designated subcommittee thereof) as to their qualifications. If found acceptable, the Executive Board will grant provisional affiliation status to the applicant church. The Executive Board will present all applicant churches to the next ~~aAnnual mMeeting~~ with an affirmative or negative recommendation.
  3. All churches receiving at least  $\frac{3}{4}$  affirmative majority at the ~~aAnnual mMeeting~~ shall be welcomed **to granted affiliation (hereinafter known as Affiliated Churches)**.
- C. Representation at Meetings of This Body.
1. ~~Each aAffiliated eChurches~~ shall be entitled to send **Messengers** to the ~~meetings of this body and these messengers shall constitute the Convention Annual Meeting~~. Each ~~aAffiliated eChurch~~ shall be entitled to two (2) ~~mMessengers~~. The number of ~~mMessengers~~ after the first two shall be calculated as follows: One additional ~~mMessenger~~ for every two hundred fifty (250) members; or for each \$250 given to the work of the SBCV with the total number of ~~mMessengers~~ not exceeding fifteen (15). Giving shall be determined for the most recent twelve-month period for which giving records are available.
  2. ~~Each mMessengers shall be approved by the aAffiliated eChurches in writing for which they represent. must be members in good standing of the church which sends them. The messengers seated by the body in its annual or any special meeting shall constitute the Convention.~~
- D. Termination of Affiliation
- Any ~~aAffiliated eChurch~~ may withdraw from this body at its discretion. This body may revoke a church's affiliation should that church cease to concur with the body's doctrinal position **or cease to contribute** to the Cooperative Program through the SBCV **for four consecutive quarters**. ~~regularly to the Cooperative Program.~~
- The Executive Board shall have all doctrinal disputes and issues related to the seating of ~~aAnnual mMeeting mMessengers~~ arising on the ~~Convention~~ floor immediately referred to them for study without further discussion. The results of such studies shall be presented to the ~~Convention~~ **Messengers** not later than the next ~~aAnnual mMeeting~~. It is required that anyone with a doctrinal concern should indicate the same in writing by letter to the Executive Director ~~two months~~ **sixty (60) days** prior to the ~~Convention Annual Meeting~~.

## ARTICLE VI~~IX~~ – MEETINGS

This body (~~constituting the Convention~~) **The Messengers** shall meet at least annually at such time and place as may be designated at a preceding ~~a~~Annual ~~m~~Meeting. Additional meetings may be called by a two-thirds vote of the Executive Board.

## ARTICLE VII~~IX~~ – AMENDMENTS

This Constitution may be amended by the ~~m~~Messengers (~~constituting the Convention~~) at any ~~a~~Annual ~~m~~Meeting of Southern Baptist Conservatives of Virginia by two-thirds vote of those voting, provided that notice of the proposed amendment shall have been given to **the member churches at least 60 days prior to the Annual Meeting**. ~~the preceding annual meeting and published in the minutes of the annual meeting.~~

## ARTICLE VIII~~IX~~ – PARLIAMENTARY AUTHORITY

The rules contained in the current edition of Robert's Rules of Order Newly Revised shall govern SBCV, its meetings of ~~m~~Messengers ~~constituting the Convention~~ **at the Annual Meeting**, committees and Executive Board, in all cases to which they are applicable and in which they are not inconsistent with the ~~a~~Articles of ~~i~~ncorporation, Constitution and Bylaws and any special rules of order the ~~m~~Messengers or Executive Board respectively may adopt.

These proposed changes to the Constitution were for information only to the 2010 Messengers and served as due notice that they will be presented for final consideration and approval by the Messengers in the 2011 Annual Meeting.***

**BYLAWS**  
**Southern Baptist Conservatives of Virginia**  
**Adopted November 2003**  
**Revised November 2010**

**ARTICLE I - OFFICERS AND COMMITTEES**

- A. General requirements for Officers, Executive Board members and all other elected or appointed positions.

To be elected or appointed to any position, an individual must be a member of an Affiliated Church that is in good standing with the Southern Baptist Conservatives of Virginia. Further, all those filling elected positions (i.e. officers, Executive Board and elected committee members) shall be required to sign a statement of concurrence with the doctrinal position of the SBCV.

- B. Officers.

The Officers of the SBCV shall be a President, First Vice President, Second Vice President, Secretary, Treasurer, and Executive Director, plus other officers as deemed necessary by the body. In accordance with the Restated Articles of Incorporation, these officers shall be ex officio members of the Executive Board with full voting rights, except the Treasurer.

The Executive Director shall be elected by the Executive Board and confirmed at a called meeting or the next Annual Meeting, to serve until termination either by resignation, retirement, or by decision of the Executive Board.

The Treasurer shall be nominated by the Executive Director and elected by the Executive Committee, to serve until termination either by resignation, retirement, or by decision of the Executive Director. The Treasurer shall serve as an ex officio non-voting member of the Executive Committee and the Executive Board.

In the event there is a vacancy in the position of Executive Director, the Executive Board shall elect an individual to fill the temporary position of Interim Executive Director until such time as the position of Executive Director is filled. All officers except the Executive Director and Treasurer shall be elected annually by the Messengers to the Annual Meeting and shall serve without remuneration for the position except for reasonable expenses with adequate documentation. No individuals (except the Executive Director and the Treasurer) shall serve more than two consecutive one-year terms in the same office.

- C. Duties of Officers.

1. The President shall preside over the deliberations of the Annual Meeting, appoint the Annual Meeting committees as provided for in Bylaws, Article IV, and their chairmen and such other duties as may be assigned to him by the Executive Board.
2. The Vice Presidents, in order, may, in the absence of the President, or when requested by the President, preside over the Annual Meeting and shall perform other duties as requested by the President.
3. The Executive Director shall serve as the Chief Executive Officer of the SBCV and shall cooperate and coordinate with the Executive Board to implement the affairs and actions of the SBCV. He shall have such other authority as the Executive Board shall authorize for the normal operation of the SBCV.
4. The Secretary of the SBCV shall keep accurate minutes of all sessions of the Annual Meeting and the Executive Board meetings and shall perform other duties as requested by the President. He shall cause these to be published together with such other information as the Executive Board deems necessary. He shall also compile and make available the official minutes of all statewide meetings, providing a copy to each member of the Executive Board.

5. The Treasurer shall serve as the Chief Financial Officer and shall cooperate and coordinate with the Executive Committee, Executive Board, and the Executive Director to implement the financial affairs and actions of the SBCV. He shall have such other authority as the Executive Director the Executive Committee, and the Executive Board shall authorize for the normal operation of the SBCV.

## **ARTICLE II - EXECUTIVE BOARD**

### **A. Composition.**

The body shall, at its Annual Meeting, elect an Executive Board as recommended by the Nominating Committee. In addition to the officers serving ex officio, this Board shall have no less than three (3) and no more than thirty (30) voting members, who fairly represent the areas/regions of the SBCV as determined by the Executive Board. An effort will be made to insure that Board membership shall be both lay and ministerial with not less than one-third from either category. The members of the Executive Board shall constitute themselves at their first meeting after election, electing the Chairman, Vice Chairman, and Secretary, and constituting the various committees. The Chairman shall not be eligible to serve more than two consecutive one-year terms in that office. No person shall be eligible to be elected Chairman who has not served for the previous year as a member of the Executive Board. The President cannot serve as Chairman of the Executive Board. No paid staff of the SBCV shall be elected as an officer or director except for the Executive Director and Treasurer.

### **B. Term of office.**

Elected Executive Board members shall serve three-year terms and be eligible for re-election to a second three-year term. Individuals completing a second consecutive three-year term will not be eligible for re-election to the Executive Board until the lapse of one year. Terms shall be constituted such that approximately one-third of the Board's terms expire in each year.

### **C. Function.**

The Executive Board shall act for the Southern Baptist Conservatives of Virginia between Annual Meetings, but it shall not alter any directive of the Messengers. The Executive Board may make recommendations at any meeting of the Southern Baptist Conservatives of Virginia.

### **D. Quorum.**

A majority of the Executive Board members in office shall constitute a quorum.

### **E. Removal and Vacancies.**

Executive Board members shall attend all Board meetings unless providentially hindered, and in such cases, notice shall be given to the Chairman of the Board, Secretary of the Board, or Executive Director. The Executive Board may declare a Board seat vacant in the event of two consecutive unexcused absences, death of a member, resignation of the member, the Committee member becoming a member of a church not affiliated with the SBCV, or the member becoming a member of a church not located in the same ministry area. In the event a vacancy occurs on the Executive Board between Annual Meeting sessions, the President shall appoint an interim replacement to serve until the next Annual Meeting.

### **F. Meetings.**

1. The Executive Board may hold regular or special meetings in or outside of this Commonwealth.
2. The Executive Board may permit any or all Board members to participate in a meeting by, or conduct the meeting through the use of, any means of communication by which all Board members may simultaneously hear each other during the meeting. A Board member participating in a meeting by this means is deemed to be present in person at the meeting.
3. The Executive Board may act without a meeting if all members of the Executive Board approve the



action in writing or email. The action shall be evidenced by one or more written or email consents stating the action taken, approved and signed by each member of the Executive Board either before or after the action taken, and included in the minutes or filed with the corporate records reflecting the action taken. Such action shall become effective when a majority of the signed consents approving the action are received, unless the consent specifies a different effective date, in which event the action taken is effective as of the date specified therein provided the consent states the date of execution by each member. A unanimous consent approved has the effect of a meeting vote and may be described as such in any document.

4. Regular meetings of the Board shall be held at a time and place set by the Executive Committee or established pursuant to a directive of the Executive Board. Special meetings of the Board shall be held upon the call of either the Executive Director, Chairman of the Executive Board or President. Notice of special meetings shall be given to each member of the Executive Board by the Executive Director, Chairman of the Executive Board or the President in writing and by first class mail, deposited at least ten days prior to the date of the special meeting.

### **ARTICLE III – EXECUTIVE BOARD COMMITTEES**

- A. Composition of Executive Board and Committees. The Executive Board shall have an Executive Committee, a minimum of three (3) standing committees of the Board and may create other committees and sub-committees, as required to carry out the work of the SBCV. The creation of any new committee or elimination of a committee shall only occur by action of the Executive Board passed by a majority of all members present at the Executive Board. The Chairman of the Executive Board shall consult with the Executive Director and the President, and upon agreement (by consensus or by majority vote) shall appoint members and chairmen of the Executive Board committees. Executive Board Committee members shall be Executive Board members.
- B. General Rules Apply. The rules declared herein for the Executive Board regarding quorum, notice of special meetings, and action without meetings shall apply to Executive Board Committees.
- C. Authority of Executive Board Committees. A committee may exercise the authority of the Executive Board only to the extent specified in the Articles of Incorporation, the Constitution or Bylaws, or by resolution of the Executive Board. In no event shall a committee fill vacancies on the Executive Board or any of its committees.
- D. Executive Committee Composition. The Executive Director and the other officers, Executive Board Chairman, and the standing Board committee chairmen shall serve as the Executive Committee with the Executive Director serving as Chairman of the Executive Committee. The Treasurer shall be a non-voting ex officio member.
- E. Executive Committee Responsibilities
  1. The Executive Committee shall meet as often as necessary to work in cooperation with the Executive Director and the Executive Board to coordinate the work of the Executive Board and its committees to carry out the work of the SBCV. The Executive Committee has all authority of the Board to accomplish the objectives between Board meetings unless prohibited by the Constitution and Bylaws.
  2. In the event of a vacancy in the office of the Executive Director, the Executive Committee shall be responsible for recommending to the Executive Board a Search Committee of seven members who shall be responsible for seeking out and recommending a person for the office of Executive Director of the SBCV.
  3. In the event of such vacancy, the Executive Committee shall also be responsible for recommending an interim Executive Director to the Executive Board.

## **ARTICLE IV – COMMITTEES OF THE ANNUAL MEETING**

- A. Annual Committees. The President shall annually appoint the following committees and a chairman of each committee.
  - 1. Resolutions Committee. This Committee shall be composed of six members who shall meet before and/or during the Annual Meeting to receive proposed resolutions from Messengers, to collate and clarify the resolutions received, and to present the resolutions deemed appropriate in finished form to the Messengers for action.
  - 2. Nominating Committee. This Committee shall consist of six persons who shall nominate at the Annual Meeting persons to fill vacancies on the Executive Board.
  - 3. Credentials Committee. This Committee shall consist of six persons and shall examine the credentials of churches desiring to seat Messengers at the Annual Meeting. This Committee shall be responsible to examine qualifications and credentials of Messengers whose seats are contested and to recommend action by seated Messengers. The Committee shall also be responsible for registration of Messengers. Any Messenger or church whose credentials are rejected shall be able to appeal such decision to the Executive Board.
  - 4. Tellers and Ushers Committee. This Committee shall consist of six persons and shall be responsible for securing and leading volunteers in distributing information and collecting and counting ballots, offerings, and other related responsibilities.
  - 5. Order of Business Committee. This Committee shall consist of six (6) persons (officers, Executive Director and Executive Board Chairman). This Committee shall be responsible for planning the Annual Meeting and its program.
- B. Special Committees. The President shall nominate special Committees as the need arises. They shall have the number of people deemed necessary and shall serve until their assigned work is completed.
- C. Committee Vacancies. A vacancy in any committee occurs in the event of death, two consecutive unexcused absences, resignation, or the committee member becoming a member of a church not affiliated with the SBCV. The President shall fill vacancies to serve for the remainder of that year.

## **ARTICLE V – GENERAL PROVISIONS**

- A. DATES OF ROTATION — Terms of office for outgoing officers, Executive Board members, and other committee members shall end on the last day of the Annual Meeting, allowing the newly elected officers and committee members to assume their responsibilities as of the conclusion of said meeting.
- B. RESOLUTIONS — Resolutions by Messengers to be adopted by the SBCV shall be submitted in writing to the Resolutions Committee before the beginning of the first session of the Annual Meeting. Resolutions submitted for adoption by the Executive Board or other standing committees shall be published at least five weeks before the Annual Meeting. Adoption of resolutions shall require a 2/3 majority.
- C. MEETINGS — The Annual Meeting of the SBCV shall convene alternately in various regions of the state as determined by the Executive Board. The Executive Board may call special statewide meetings provided a notice is given thirty days in advance stating the specific purpose for such meeting. Action at such meetings will be limited to matters specified in the advance notice of the meeting. Those Messengers present shall constitute the quorum.
- D. MINISTRY AREAS/REGIONAL GROUPS — For the sake of geographical identity for Executive Board representation and for ministries and services, the SBCV shall be divided into as many region/ministry areas as deemed necessary. Local groups may form for the purpose of fellowship and training according to clusters of population of churches and the availability of meeting facilities and leadership.

- E. **MEMBER CHURCH OBLIGATIONS** — Member churches are urged to be involved and supportive of the direction of the SBCV. It is expected that member churches of the SBCV will endeavor to maintain a positive Christian witness, and involve themselves in the operation and success of the SBCV and, that said participation involves time investments and financial contributions given regularly as Cooperative Program support through the SBCV. The Executive Board shall be responsible to contact any church failing to maintain a positive Christian witness and/or failing to financially support the Cooperative Program through the SBCV for a period of one year, and seek to restore the member church; and, if necessary, recommend to Messengers in the Annual Meeting that the church's affiliation be rescinded.
- F. **BAPTIST FAITH AND MESSAGE**--All Board Members, Officers, Missionaries, and managerial staff of the Southern Baptist Conservatives of Virginia and its subsidiaries are expected to agree with and fully support SBCV's current doctrinal position and shall complete a signed statement of such doctrinal affinity. Failure to demonstrate concurrence with the doctrinal stance of the Southern Baptist Conservatives of Virginia shall be sufficient reason for termination from their respective positions.
- G. **FRATERNAL AND OTHER RELATIONSHIPS**
  - 1. **Non-Affiliated Churches** -- Southern Baptist Conservatives of Virginia welcomes individuals who are members of non-affiliated churches to attend any of its general meetings insofar as seating will allow. Such individuals may attend but may not vote, speak to business matters, or hold any elected office within the Southern Baptist Conservatives of Virginia.
  - 2. **Ministry Based, Other Non-Profits, and For-Profit Entities**—The SBCV welcomes opportunities to work with other organizations that may enhance the goals and ministries of the SBCV and its affiliates.
- H. **AMENDMENTS** — These Bylaws may be amended by the Messengers at any Annual Meeting of Southern Baptist Conservatives of Virginia by majority vote of those present and voting, provided that notice of the proposed amendment(s) shall have been given to the Affiliated Churches at least sixty days in advance of the Annual Meeting.

Footnote—The Bylaws were adopted at the 2003 Annual Homecoming and this document includes revisions that were approved at the 2010 Annual Homecoming.
